



**DENVER BILINGUAL LEGAL ADVOCATE
JOB DESCRIPTION**

SUMMARY:

The duties of the Denver Bilingual Legal Advocate are to provide advocacy, support and other services to individuals who have experienced domestic violence, sexual assault or stalking and are seeking protection through the court system in the 2nd Judicial District (Denver, CO). This position provides services in the Project Safeguard office at the Denver County Courthouse near Downtown Denver. The Bilingual Legal Advocate coordinates services with civil/criminal justice systems, domestic violence shelters, mental health, human services, children's programs and other area agencies.

The successful candidate will have a passion for meeting the needs of and advocating for the Latinx immigrant and non-immigrant communities and will be able to provide all services in both English and Spanish.

RESPONSIBILITIES:

- Provide intervention, assistance, safety planning and referrals to domestic violence victims through phone and in-person contacts
- Work with the team of Project Safeguard bilingual advocates to develop and implement best practices for serving Latinx individuals experiencing domestic and/or sexual violence
- Facilitate daily protection order assistance
- Facilitate Tuesday evening Divorce/Custody clinics in rotation with other Legal Advocates
- Accompany clients to temporary and permanent protection order hearings and other court proceedings as appropriate
- Network, interface, and advocate with other systems, treatment, and service provider agencies on behalf of Project Safeguard and its clients
- Establish/maintain a positive working relationship with judicial officers and clerks in the protection order courtrooms
- Maintain a close working relationship with other Project Safeguard staff for support
- Attend all required Project Safeguard staff meetings and trainings
- Attend community meetings as appropriate and/or assigned
- Provide technical assistance and training to agencies on Project Safeguard services and/or domestic violence
- Attend, facilitate and/or establish meetings to problem solve, network and assist in the assessment and development of domestic violence policies and procedures
- Maintain a positive working relationship with advocates from both community and system-based agencies
- Maintain accurate and current client and programmatic records, data, and statistics as required
- Other duties as assigned by supervisor

KNOWLEDGE, SKILLS AND ABILITIES REQUIRED:

- Strong working knowledge of domestic and sexual violence, including demonstrated skills in individual advocacy

- Commitment to understanding domestic and sexual violence in the context of societal oppressions
- Commitment to providing trauma-informed, victim-centered, services.
- Curiosity and Interest in social justice and working to help legal systems work better for survivors
- Excellent written and oral communication skills, including active listening skills
- Problem-solving ability and a willingness to help survivors find creative solutions
- Ability to function independently and as a team member
- Must exhibit a positive collaborative attitude.
- Fluency in Spanish and with general legal terms is required for this position
- Proficiency in Microsoft Office products and general computer literacy strongly preferred

Project Safeguard values diverse life experience and is an Equal Opportunity Employer. Survivors of intimate partner violence, people of color, people with disabilities, and/or people who identify as LGBTQI are encouraged to apply.

This is a full-time, non-exempt position. Starting salary is \$17.15/hour. Benefits include parking or transit pass, health, dental, vision, disability and life insurance, and employer-matched retirement plan.
